Royce Global Value Trust, Inc. (NYSE-RGT) declares Year-end Common Stock Distribution of \$0.15 Per Share

Royce Global Value Trust, Inc. (NYSE-RGT) (the “Fund”) has declared a year-end distribution of \$0.15 per share on its Common Stock. The distribution, optionally payable in additional shares of Common Stock, or in cash by specific stockholder election, is to be paid on December 22, 2023 to stockholders of record at the close of business on December 11, 2023 (ex-dividend on December 8, 2023). The price of shares issued for reinvestment will be determined on December 18, 2023.
