The distribution, optionally payable in additional shares of Common Stock, or in cash by specific stockholder election, is to be paid on June 27, 2017 to stockholders of record at the close of business on June 13, 2017 (ex-dividend on June 9, 2017). The price of shares issued for reinvestment will be determined on June 20, 2017.

The reinvestment price is determined on the valuation date by the lower of the last reported sale price at the close of regular trading on the Funds' listing Exchange or the net asset value per share on the valuation date (but not less than 95% of the last reported sale price on that date).

RVT and RMT estimate that they have distributed more than their income and net realized capital gains; therefore, a portion of your distribution may be a return of capital. A return of capital may occur, for example, when some or all of the money that you invested in a Fund is paid back to you. A return of capital distribution does not necessarily reflect RVT or RMT's investment performance and should not be confused with 'yield' or 'income'.
