The distribution, optionally payable in additional shares of Common Stock, or in cash by specific stockholder election, is to be paid on September 23, 2022 to stockholders of record at the close of business on September 12, 2022 (ex-dividend on September 9, 2022). The price of shares issued for reinvestment will be determined on September 19, 2022.

The reinvestment price is determined on the valuation date by the lower of the last reported sale price at the close of regular trading on the Funds' listing Exchange or the net asset value per share on the valuation date (but not less than 95% of the last reported sale price on that date).

The Funds estimate that they have distributed more than their income and net realized capital gains; therefore, a portion of the Funds' distributions may be a return of capital. A return of capital may occur, for example, when some or all of the money that you invested in a Fund is paid back to you. A return of capital distribution does not necessarily reflect the Funds' investment performance and should not be confused with 'yield' or 'income'.
